

# Terms and Conditions

These are the Terms and Conditions on which CPL – Choice, Passion, Life ABN 27 009 942 269 (**CPL**) will make determination and offer prizes in the win your way to Brisfest (**Competition**). By participating in this Competition, you (**Participant**) agree to these Terms and Conditions. The Participant further waives, releases, and holds CPL, its directors, employees, subcontractors, volunteers, agents and associates harmless for any claims and liabilities whatever so arisen in connection with the Competition.

## 1. The Competition

- 1.1. The Competition is open to all current clients and staff.
- 1.2. Entries to the Competition must be completed by 7 August 2023.
- 1.3. The theme of the Competition is titled: Win your way to Brisbane Festival and the participants are to submit entry (**Statements**) to promote the BrisFest 2023 between the periods of 10 July – 7 August 2023.
- 1.4. The Participant must ensure that the Statements made are:
  - consistent with the promotional requirements listed in clause 1.3;
  - are original work of the Participant;
  - is not defamatory or disrespectful;
  - will not be seen as a statement which would damage the image or reputation of CPL, the BrisFest2023, the Competition and all sponsors to CPL and BrisFest.
- 1.5. Entries must be submitted via the designated online form as advised by the business. (**Entry**)
- 1.6. A Participant must request travel assistance at the time of submitting the Entry. CPL reserves all right with respect to grant travel assistance to the Participant should the Participant wins the Competition.

- 2.1. The winners will be announced in or around July and August and will be privately notified.
- 2.2. The total prize pool is valued at \$10,000.
