Membership will include past and present CPL Group clients, as well as members with a special interest in disability and/or aged care, and inclusion.

The Advisory Board is not a decision-making body, rather a board that provide advice and recommendations to the executive team to find new innovations that will positively influence the lives of people with disability, and older Australians living at home.

What will the Advisory Board do?

Advisory Board Members will:

- Apply a shared and diverse perspective on issues relevant to the interests of CPL Group
- Provide advice that will support CPL Group's executive team in the performance of their Strategic Plan
- Give recommendations on the conceptualisation, focus, structure, and performance of current and future projects
- Maintain a culture for CPL Group that is consistent with the CPL Group Client Charter, NDIS Code of Conduct and the Charter of Aged Care Rights
